**Public Inspection Report**

**December 5, 2016 Opening Inspection Copper Mine**  
No Major Violations Cited  
Follow up Inspection in 2-3 weeks.

**December 6, 2016 Playhouse Bistro Routine Inspection.** No Violations Cited.

**December 7, 2016 Presbyterian Manor follow up inspection.** All violations have been corrected.

**December 8, 2016 Underground 1851 Routine Inspection.** One non-priority violation cited. Dirty non-food contact surfaces.

**December 9, 2016 Breaktime on Bluff St. Routine Inspection.** Four Priority violations & three non-priority violations. Dirty food contact surfaces, employees not washing hands, potentially hazardous items past discard date, food items open at risk for contamination, three compartment sink dirty not properly clean or sanitized. Follow up required.

**December 12, 2016 GoPo's Opening Inspection.** Six Priority violations and five non priority violations. Dirty food contact surfaces, cross contamination, exposed wiring, date labels, no mop sink, HACCP plan, dirty nonfood contact surfaces, improper drain board, broken/holes/cracked walls, ceiling, floors and doors leaving means or egress for pest. Did not pass opening inspection. Follow up inspection at request of operator when all violations have been corrected.

**December 15, 2016 GoPo's Follow up inspection.** One non-Priority violation. Dirty Nonfood contact surfaces. Pass to open will follow up in 2-3 weeks.

**December 16, 2016 Breaktime on Bluff St. All violations corrected.**

**December 14, 2016 Mueller Hall Routine Inspection.** Two non-priority violations. Mechanical ventilation not working in restroom, mop sink backing up drainage problems. Maintenance was called while on site, work order was placed to correct issues.

**December 29, 2016 Wal-Mart Routine inspection.** One non-priority violation. Caulking around 3 compartment sink in deli/bakery needs to be replaced. Mold and buildup.

**December 30, 2016 Pizza Hut Routine Inspection.** One non-priority violation cited. Corrected on site.
