Raw meat above RTF, RTF past discard date, no date labels, sanitizer rags  
Improperly stored, food stored on floor of walk in cooler/freezer, packaging  
Open food at risk for cross contamination. **Follow up required.**

**Busy Corner 2/15/17 9 Priority Violations and 3 non-priority violations**

Potentially hazardous foods out of temperature, dirty food contact surfaces, potentially  
Hazardous food not labeled and dated, containers open at risk for cross contamination,  
Failure to demonstrate a person in charge, failure to provide temperature logs and disposal records, unnecessary trash and debris, no  
thermometers in walk in cooler, refrigeration equipment not holding temperature, failure to obtain approval to operate.

**Busy Corner 2/16/17 Two Priority Violation and 1 non-priority violation**

Failure to obtain approval to operate, failure to provide temperature logs and disposal records, unnecessary trash and debris. **Follow up Required**

**Bristol Manor 2/21/17 One Priority Violation Three Non-priority violations**

Employee not washing hands properly, wiping cloths not stored in sanitizer, single service items  
stored improperly, no towels at hand sink **\*All violations CORRECTED ON SITE\***
