Honey Bear Diner 4 Opening Inspection /10/17 Six priority Violations and Four Non-Priority violations-failing plumbing and backflow prevention system, DFC surfaces, improper storage of toxins, employees not washing hands, PHF not held at 41°f and below, refrigeration equipment not maintaining temp., unnecessary trash and litter in enclosure area, dirty NFCS areas from infrequent cleaning. **FOLLOW UP REQUIRED**

Honey Bear Diner 4/19/17-Two Priority Violations and Two non-priority violations: Dirty food contact surfaces, failing or improper plumbing system, unnecessary trash, clutter and debris around the exterior of the building and trash receptacle creating pest harborage, trash enclosure in poor and dangerous condition, Exterior door will not close at all. Completely rusted out along the bottom, the hinges are bent and sprung, along the bottom and sides of door there is a 2-3 inch gap creating means of egress for pest, rodents, and does not protect the building from weather conditions. -Follow up required
