General Conditions

Intent of Specifications

It is the intent of these specifications to describe the requirements and conditions for furnishing and delivering the specified treatment wood poles. It is the intent of these specifications that all material and the treatment thereof must be in full compliance with RUS Bulletin 1728F-700 "RUS Specification for Wood Poles, Stubs, and Anchor Logs" and RUS Bulletin 1728H-702 "RUS Specification for Quality Control and Inspection of Timber Products" with the following revisions:

Sweep

A pole may have sweep subject to the following limitations: A straight line connecting the midpoint of the butt with the midpoint of the top shall not at any intermediate point pass through the external surface of the pole.


Knots

In addition to the limit of knot sizes as outlined in RUS Bulletin 1728F-700, knot clusters (defined here as 2 or more knots grouped together with the grain of the wood deflected around the knots) shall be prohibited. Furthermore, ring knots (defined here as four or more knots with the pith of the knots within 2" or less of the same radius around the pole) shall be prohibited

SD Shipment & Delivery

- Pole shipment shall be on a self-unloading truck. The destination to use for bidding sp purposes will be as follows
- Poles should be checked in at the City of Fulton Warehouse at 1303 Westminster Ave, SD 2 Fulton, MO.
- Delivery drivers will be escorted by receiving staff to the City of Fulton Pole Yard located on SD 3 Industrial drive in Fulton MO. Where the poles will be off loaded

IN-CITY VENDOR PREFERENCE

Tie Bids. If all bids received or the lowest bids received are for the same total amount or unit price, quality and service being equal, the Contract shall be awarded to a local bidder. Where there is no low city bidder, the award shall be made on the basis of drawing lots, to be held in public.

PREPARATION OF BIDS

- Bidders are expected to examine the specifications, delivery schedule, bid prices and all instructions of the IFB. Failure to do so will be at bidder's risk. In case of a mistake
- in extension, the unit prices(s) will govern.

 Any manufacturer's names, trade names, brand names, information and/or catalogue Any manufacturer's names, trade names, brand names, information and/or catalogue numbers listed in a specification are for informational purposes only and are not intended to limit competition. The bidder may offer any brand which meets or exceeds the specifications for any item. If bids are based on equivalent products, indicate on the bid form the manufacturer's name and model number. The bidder shall explain in detail the reasons why the proposed equivalent will meet the specifications and not be considered an exception thereto. Bids which do not comply with these requirements are subject to rejection. Bids lacking any written indication of intent to bid an alternate brand will be received and considered in complete compliance with the specifications as listed on the bid forms. as listed on the bid forms.
- All supplies and equipment offered in a bid must be new and of current production unless the IFB clearly specifies that used or reconditioned supplies or equipment may
- Firm fixed prices shall be bid and include all packing, handling and shipping charges. Unless otherwise indicated, prices quoted shall be firm for acceptance for ninety days from bid opening and for the specified contract period.

SUBMISSION OF BIDS

- A bid submitted by a bidder must (1) be manually signed by the bidder on the Division of Purchasing IFB form, (2) contain all information required by the IFB, (3) be priced as required, (4) be sealed in an envelope or container, (5) be attached to a security deposit if required and (6) be delivered to the division of Purchasing and officially clocked in no later than the exact time and date specified on the IFB.

MODIFICATION OR WITHDRAWAL OF BIDS

BID OPENING

AWARDS

- By virtue of statutory authority, a preference will be given to materials, products, supplies, provisions and all other articles produced, manufactured, made or grown within the State of Missouri, when all other factors are equal.

 Unless otherwise stated in the IFB, cash discounts for prompt payment of invoices will no be considered in the evaluation of prices. However, such discounts are encouraged
- to motivate prompt payment.
- As the best interest of the City of Fulton may require, the right is reserved to make awards by item, group of items, all or none or a combination thereof, on a geographic district basis and/or on a City of Fulton basis with one or more suppliers; to reject any and all bids or waive any minor irregularity or technically in bids received.

 Awards will be made to the bidder whose bid (1) meets the specifications and all other requirements of the IFB and (2) is the lowest and best bid, considering price,
