Sec. 110-358. Zones; fees.

(a) Parking in the following designated areas shall be for a period of time not to exceed three hours. Parking for successive periods of time within the same parking zone is prohibited. For the purpose of this subsection, a zone shall constitute both sides of the street of a city block:

Court Street, east side, from Third Street to Fourth Street, except for driveways.

Court Street, west side, 114 feet south of the south curb of Fourth Street, thence south 216 feet, except for driveways.

Court Street, from Fourth Street to West Seventh Street.

Jefferson Street, between West Fifth Street north to West Sixth Street, six spaces on the west side.

Nichols Street, from West Fifth Street to West Sixth Street.

Nichols Street, east side, from West Sixth Street to West Seventh Street.

Ravine Street, west side, from East Fourth Street to East Fifth Street.

Ravine Street, from East Fifth Street to East Sixth Street.

St. Louis Avenue, south side, from Court Street to Market Street.

West Fourth Street, north side, from Court Street to Nichols Street.

East Fifth Street, north side, from Market Street to 200 feet east of Ravine Street.

East Fifth Street, from Ravine Street east 200 feet on the south side.

East Fifth Street, from Market Street to Court Street.

East Fifth Street, north side, between Ravine Street and Market Street.

West Fifth Street, from Court Street to Jefferson Street.

East Sixth Street, from Ravine Street to Market Street.

East Sixth Street, from Market Street to Court Street.

West Sixth Street, from Court Street to Nichols Street.

West Sixth Street, north side, between Nichols Street and Jefferson Street.

East Seventh Street, from Market Street to Court Street.

(b) Parking in the following designated areas shall be for a period of time not to exceed 20 minutes. Parking for successive periods of time within the same parking zone is prohibited. For the purpose of this subsection, a zone shall constitute both sides of the street of a city block:

East Fourth Street, from Market Street to Court Street.

(c) A vehicle shall be unlawfully parked if it remains in the zone beyond the legal parking limit. Violators shall be subject to a fine as provided in section 110-312(c) and (e).

WHEREAS, this was previously a four-year contract, the Callaway County Collector and Commission have requested that it is limited to one year at this time of writing.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF FULTON, MISSOURI, AS FOLLOWS:

<u>SECTION ONE</u>: The Council hereby authorizes the execution of a contract between the City of Fulton, Missouri, and the Collector and County Commissioners of Callaway County, Missouri, concerning the collection of City Taxes. A copy of the unexecuted contract is attached hereto and marked "Exhibit A" and incorporated herein by reference as if fully set out at this point.

<u>SECTION TWO</u>: The Council authorizes the annual payment of \$6,000.04 for the aforementioned services.

<u>SECTION THREE</u>: The Council finds and determines that the execution of said contract by the City is in the best interest of the City.

<u>SECTION FOUR</u>: The Mayor and City Clerk are hereby authorized and directed to execute said Contract on behalf of the City of Fulton, Missouri.

WITNESSETH:

WHEREAS, the City of Fulton is a taxing authority under the constitution and laws of the State of Missouri; and

WHEREAS, the Callaway County Collector and Callaway County Commission are each concerned with the billing and collection of taxes for the State of Missouri and Callaway County, Missouri, and other political subdivisions of the state; and

WHEREAS, all the parties desire to consolidate the billing and collection of taxes, lawfully levied by the City, with the billing and collection of other state and county taxes; and

WHEREAS, The County Commission of Callaway County, Missouri, has made an order authorizing Gary Jungermann, Presiding Commissioner to execute this contract on behalf of the County; and

WHEREAS, the City Council of the City, has by ordinance authorized Steve F. Myers, Mayor to execute this contract on behalf of the City;

NOW THERFORE, In Consideration of the sums hereinafter set out to be paid by the City to the Callaway County Treasurer and the Callaway County Collector of Callaway County, Missouri, it is agreed as follows:

1. That the Collector of Callaway County, Missouri, will provide the billing and collection of the real estate taxes, personal property taxes, city sticker fees and special assessments fees for the City of Fulton. The County Collector will also collect and disburse any payments in lieu of taxes for any areas established by the City of Fulton under the "real Property Tax Increment Allocation Redevelopment" law, Section 99.800 et. Seq., RSMo and that

- Callaway County will provide the facilities needed by the Collector to do the same.
- 2. That all taxes collected by said County Collector shall be paid to the City of Fulton on a monthly basis via electronic transfer.
- 3. That inconsideration for doing the complete billing and collection of taxes for the City of Fulton, the City of Fulton will pay directly to the County Treasurer for the County Collector of Callaway County the sum of five thousand dollars annually which all parties agree may be retained by the County Collector as compensation in addition to all other compensation provided by law under authority of Section 50.332 RSMo. Supp. 1986. Said payments shall be made to the Collector in monthly installments of four hundred sixteen dollars and sixty-seven cents, beginning March 1, 2023. The city will pay to the County Treasurer of Callaway the additional sum of one thousand dollars annually as consideration to Callaway County for the use of county facilities for the collection and billing of City of Fulton taxes.
- 4. That the penalties for non-payment of city taxes shall be made to conform by the City to the corresponding penalties charged by Callaway County, which is eighteen percent (18%) per annum.
- 5. That the County Collector shall follow the same procedure for the collection of delinquent City real estate taxes as it is prescribed by the statutes of the State of Missouri for the collection of delinquent county real estate taxes, including all necessary sales of real estate. City personal property taxes shall, before the expiration of the statutes of limitation, be certified by the County Collector to the City Attorney of the City, who shall institute and prosecute such suites.
- 6. One percent (1.0%) of all ad valorem taxes collected by the County on behalf of the City shall be withheld as provided for in Section 137.720, RSMo, for the County Assessment Fund. Additionally, one-half of one percent (.50%) of all ad valorem taxes collected by the County on behalf of the City shall be withheld as provided for in Section 137.720.3, RSMo, for the County Assessment Fund effective July 1 2009. This half percent is capped at \$75,000 and the encumbrance of withholding is equally imposed on all taxing entities. These percentages will remain as noted unless the Missouri State Legislature directs them to change.

- 7. That the City of Fulton, Missouri, may at least once a month, so as not to interfere with the orderly business of the County Collector's Office, inspect and audit the books for the County Collector pertaining to the collection of municipal taxes.
- 8. That the term of this contract shall begin upon signing and continue through <u>June</u>, <u>2024</u>, unless sooner changed by operation of law, or by either party giving written notice sixty days before the anniversary date of the contract that they intend to terminate the relationship.
- 9. That upon termination of this contract, the County Collector shall make available to the City of such tax records as may be necessary to enable the City to collect the current year's real, personal property and vehicle license taxes, as well as delinquent real and personal property taxes as may be carried on the books of County Collector at the time of termination.
- 10. The County Collector shall furnish additional bond in such amount as may be agreed upon by the Callaway County Commission and City of Fulton.
