#### DISCUSSION

#### **1. CALL TO ORDER**

The meeting was called to order at 5:30 p.m. with Commission Chair Joan Berry-Morris presiding.

### 2. ROLL CALL

Seven members present, one absent. Quorum met.

#### **3. ELECTION OF OFFICERS**

Chair Morris opened the floor to begin the process of choosing officers. One commissioner readily voiced support for keeping the current officers in their positions, which was met with a resounding agreement from other commissioners. Commission members agreed to keep the current officers in place by a voice vote with seven members in favor, one absent (Newsom), and none opposed.

#### 5. APPROVAL OF NOVEMBER 28, 2023, MINUTES

### 6. PUBLIC HEARINGS (2)

Public Hearing #1: 303 Claymine Drive

Chair Morris declared the hearing open at 5:32 p.m. Morris said the hearing was being held to determine if the tract of land located at 303 Claymine Drive should be rezoned from R-1 to R-2 Residential.

Chair Morris gave three calls for anyone to speak in favor of the zoning change. No one responded. Chair Morris then gave three calls for anyone to speak in opposition of the zoning change. No one responded.



Chair Morris declared the hearing closed at 5:33 p.m.

## Public Hearing #2: 707 W. Chestnut Street

Chair Morris declared the hearing open at 5:33 p.m. Morris said the hearing was being held to determine if the tract of land located at 707 W. Chestnut should be rezoned from R-1 to R-2 Residential.

Chair Morris gave three calls for anyone to speak in favor of the zoning change. No one responded. Chair Morris then gave three calls for anyone to speak in opposition of the zoning change. No one responded.

Chair Morris declared the hearing closed at 5:34 p.m.

# 7. ZONING CHANGE DISCUSSIONS AND RECOMMENDATIONS

During the meeting, Eible acknowledged that both perspectives presented were valid. Morris expressed agreement. Additionally, Eibel shared the opinion that a new development on Chestnut would be a positive and valuable addition.

**Decision**: Motion was mad by Les Hudson and Seconded by Ron Oldani to recommend the zoning change request made for the tract of land located at 303 Claymine Drive for passage by the City Council. Six members in favor, one absent (Newsom), and one member recused himself from the vote. (Eibel). Motion carries.

**Decision**: Motion was mad by Mike Eibel and Seconded by Ron Oldani to recommend the zoning change request made for the tract of land located at 707 W. Chestnut Street for passage by the City Council. Seven members in favor, one absent (Newsom). Motion carries.

# **8. OTHER BUSINESS**

### Recreation Vehicle Zoning Update

City Engineer Bruemmer reported no new updates on RV zoning. Mayor Myers said that in a conversation with a representative from Westminster University, the university opposed the zoning, citing the campus doesn't have a need for RV parking (as was discussed as a potential need in a previous meeting). Vice Chair Oldani expressed opposition to having it within city limits. Chair Morris stated that a resident requested us to assess the matter, and we have a responsibility to fulfill that request.

### Planning & Protective Services Manager

Bruemmer stated that the city is actively hiring for a Planning & Protective Services Manager.
